	Tyres, of a kind used on motor cars (including station wagons and racing cars) (4011) Inner tubes (4013)	Safety specifications and testing methods for new tyres, manufactured either domestically or abroad, used on light trucks, vans, heavy lorries, tractor trucks, buses and trailers, sold in the country, whose identification codes are listed in the Standard together with those added in the future. Requirements: tread wear indicators in the grooves to show when the tread band is worn to 1.6 mm, which is considered the tyre safety limit.
