<u>Negotiating Proposal on</u> <u>Tariff Elimination in the Gems and Jewellery Sector</u>

Communication from Hong Kong, China; Japan; the Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu; Singapore; Switzerland; Thailand and the United States

Addendum

The following communication, dated 20 July 2006, is being circulated at the request of the Delegations from Hong Kong, China; Japan; the Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu; Singapore; Switzerland; Thailand and the United States.

I. INTRODUCTION

1. As proposed in the previous communication of 21 September 2005 (ref. TN/MA/W/61) and 7 November 2005 (ref. TN/MA/W/61/Add.1), tariff elimination in the gems and jewellery sector is another key element to achieving the objectives of the Doha Development Agenda. The participation of Members who are significant producers and traders is necessary for a successful trade liberalization, which in turn promotes economic growth and development. Since the nature of the gems and jewellery industry is composed of several stages where many countries, both developed and developing, involve in, this initiative will benefit each one by increasing trade at every stage of the supply chain.

2. Taking into consideration the Ministerial Declaration adopted on 18 December 2005 (ref. WT/MIN(05)DEC), which instructed the Negotiating Group to review proposals with a view to identifying those which could garner sufficient participation, the following proposal is made for consideration of all Members.

II. MODALITIES

A. PARTICIPATION

3. As agreed in paragraph 16 of the Hong Kong Ministerial Declaration, participation should be on a non-mandatory basis. A gems and jewellery sectoral initiative in the Doha Development Round should include WTO Members that are key traders as well as producers that have the potential to impact international markets through trade. Critical mass will be attained when sufficient Members agree to participate in this initiative such that their combined total trade reaches a threshold to be determined by Members. To date, interested Members have proposed a critical mass of countries representing [90] percent of total WTO's Members' trade in the agreed product coverage.

B PRODUCT COVERAGE

4. A gems and jewellery sectoral initiative should be as comprehensive as possible and simple for participating Members to implement. Therefore, the product coverage should be broad and cover a range of products within the supply chain of the gems and jewellery sector, while taking into account the diverse nature of these products.

5. It is proposed that the product coverage of this sector should cover articles under Chapter 71 of the Harmonized System, which includes pearls, diamonds, precious stones, synthetic stones, silver, gold, platinum, jewellery, and other articles of the products aforementioned, imitation jewellery, and coin. A tentative suggestion for product coverage on the gems and jewellery sector is shown in Annex 1. Additional products of interest to participating Members may be added to the list for consideration. The ultimate decision on product coverage rests with the participants in the agreement.

C TARGET RATE AND IMPLEMENTATION

6. This sectoral initiative aims at immediate elimination of tariffs on gems and jewellery products. Such tariff elimination would commence when the agreed critical mass is attained and in accordance with the special and differential treatment outlined below.

D SPECIAL AND DIFFERENTIAL TREATMENT

7. Flexibility in implementation of the process could be employed to account for the needs of developing countries. For certain highly sensitive products, up to [X]% of [total value of a Member's import] in the agreed product coverage, Developing Members may elect to implement this agreement based on the following three-step staging.

- First, each Member has to reduce its bound tariffs of those specific tariff lines to [Y] % or the post-formula values, whichever is the lower, over $[Z_1]$ years in equal installments.
- Second, Members may maintain the tariff rate(s) achieved in the first step, without any reduction, for $[Z_2]$ years.
- Finally, after the first two steps are attained, Members has to eliminate bound tariffs without further staging.

8. Additional proposals for special and differential treatment are welcomed. Specific conditions and limits for flexibility option will be further discussed while all elements of special and differential treatment will be ultimately decided by the participants in the agreement.

E MISCELLANEOUS ELEMENT

9. Nothing in this sectoral initiative shall prevent participating Members to exercise control over movement of gold or silver as necessary in accordance with Article XX and Article XXI of the GATT 1994.

III. NEXT STEPS

10. The results of this negotiation will be incorporated into each participating Member's schedule of commitments.
