#### COMMUNICATION FROM THE EUROPEAN COMMUNITIES

Revision

The following communication, dated 10 October 2008, is being circulated at the request of the Delegation of the European Communities.

#### TECHNICAL ASSISTANCE AND CAPACITY BUILDING

1. This submission provides an update of EC technical assistance and capacity building programmes in the field of Trade Facilitation (the previous list of programmes was submitted in document TN/TF/W/149 of 27 September 2007). Annex 1 sets out the projects financed at the EC level. Annex 2 gives a number of examples of programmes by EC Member States. Some examples of broader infrastructure projects, including those relating to improving transit corridors, while not part of the WTO agenda, have also been included (Annex 3) for information purposes since such projects can help maximize the benefits of Trade Facilitation reforms.
